### **CIRCULAR**

Members of the Society are informed that General Body Meeting held on Saturday 27 June, 2015 has taken following decisions:

The members who wants to withdraw from the membership of the Society he/she will be refunded entire amount provided he/she provides an appropriate substitute member and in case no substitute is available/provided, in that situation, 5% of the deposited amount will be deducted and rest of the amount would be refunded to the outgoing member subject to availability of fund.

The members who have paid only one or two installments of land cost pay the remaining amount within 30 days from the date of receipt of the notice or uploading the notice on the website, failing which his/her membership shall be cancelled without further notice and the admissible amount would be refunded.

Those members who have not deposited any installments towards land cost they may be given last opportunity to withdraw their Membership fee of Rs. 5000/- (though not refundable) deposited with the society within one month of this notice after which no amount will be refunded to these Members. This may be treated as the final notice to this category of Members.

The General body unanimously elected S/Shri Tek Chand and Lalit Kumar Sharma against the vacant positions in the Governing Body and decided that the same Governing Body shall continue for the next 02 years i.e. up to 30<sup>th</sup> June, 2017. 
